

His presentation was on the moral responsibilities of affluent individuals in addressing poverty, and, more specifically, how "Rawlsian liberalism and Christian political thought can prematurely close dialogue about grave moral matters." ### Race and Religion Speaker Series

The Race and Religion Speaker Series will feature influential scholars in the field and is made possible by the Religious Studies Department, Africana Studies, and the Dean of Arts & Sciences. This year, we will host two guest speakers: Dr. [Abdulbasit Kassim](#) on November 1st at 12pm in James Blair Hall Room 229 and Dr. [Laura McTighe](#) on November 15th at 12pm in James Blair Hall Room 229. Dr. Kassim's lecture will "trace the intellectual history of the theological and juridical debates on the typologies of enslavement, the racist association of blackness with slavery, and the deployment of classical legal rulings on slavery in the religious conceptions of difference in our present day." On the 15th, Dr. McTighe will lecture on abolitionist movements made possible through Black feminisms, Black religions, and public humanities.
