## ***The William & Mary Theatre Scholarship Disbursement Guide***

What to expect if you are selected as the recipient of the William & Mary Theatre Scholarship:

The William & Mary Theatre Scholarship can be disbursed in several ways, depending on the reason stated on your application.

- 1) If you are awarded the WMT Scholarship for **summer theatre studies at another institution**, and you will not be enrolled in summer courses at William & Mary, you will be paid directly through Accounts Payable.  
If you will be enrolled in summer classes at William & Mary, your award will be disbursed by the Financial Aid Office and may be affected by other summer aid. You should consult with your financial aid counselor to determine how this award would affect other summer aid.
- 2) If you are awarded the WMT Scholarship to assist with a **summer internship**, the award will be paid to you through Student Employment. You will need to complete an I9 if you do not already have one on file. If you are a current student employee working on campus, you should have a valid I9 on file. You can verify this with the department administrator.
- 3) If you are a graduating senior and are awarded the WMT Scholarship to assist with the cost of **graduate studies at another institution**, you will be paid by Accounts Payable and will need to complete an on-line registration in the university's payment system, BuyW&M. The department administrator will request an invitation for your registration.
- 4) You may apply for the William & Mary Theatre Scholarship to help **offset the cost of your current enrollment at William & Mary**. Please be aware that if the total cost of attendance this year (tuition & fees, room & board, and estimated indirect costs) has been met with grants and scholarships in your William & Mary financial aid package, you can be awarded this scholarship, but you might not receive a cash disbursement. There are many possible scenarios for how the award may be applied (such as offsetting loans), so please speak to your financial aid counselor to review the specifics in your case.

**It is the policy of the Department of Theatre & Performance to award deserving students in our programs. If you are awarded but do not receive a cash disbursement, you have been recognized for your achievements and given a distinction that will follow you throughout your career. Please Apply!**
