Nomination Statement

A nominee's record of superior accomplishment must demonstrate clear and compelling evidence of involvement/participation; effectiveness/success; impact/achievement; and recognition/acknowledgement. The nature, level, and/or degree of this evidence must also be reflective of William & Mary's mission. Please prepare a statement of approximately two, but no more than three, pages containing the elements listed below. You may structure this statement as a letter to the selection committee or write a paragraph addressing each item and labeled with an appropriate header.

1. A brief introduction (appropriate for a generalist audience) to what you consider the most compelling elements of your nominee's career.
2. A description of your nominee's accomplishments related to **teaching**. A record of superior accomplishment should contain clear and compelling evidence related to instruction, student development and learning, and promotion of success for students of all backgrounds.
3. A description of your nominee's accomplishments related to **discovery**. A record of superior accomplishment should contain clear and compelling evidence related to scholarly works (objective, subjective, and/or artistic) and scholarly activities (new knowledge and research).
4. A description of your nominee's accomplishments related to **knowledge integration**. A record of superior accomplishment should contain clear and compelling evidence related to curricular development, including placing the nominee's discipline in larger interdisciplinary and cross-disciplinary contexts, and meaningful connections between a nominee's discovery, research, creative output, and teaching.
5. A description of your nominee's accomplishments related to **service**. A record of superior accomplishment should contain clear and compelling evidence related to the application of knowledge and expertise in the broader contexts of the institution, community/society, and professional service.
6. An explanation of how your nominee's achievements have particular connection with or impact on the Commonwealth of Virginia, if applicable.
7. Any additional information or impressions you believe the Selection Committee should consider in evaluating your nominee.
